[What information do we collect about you?](#)

Lie Detector Investigations may collect data including personal data which you have chosen to voluntarily submit to us. The submission of data can be collected upon completion of an online form, contact form, via email, via telephone, a customer survey or feedback form, through one of our blogs and/or posts or through the use of any of our social media platforms.
